Office Directions

From Downtown to Cottonwood Heights

- Take I-15 Southbound
- Merge onto I-80 E toward Cheyenne
- Keep right to merge onto I-215 S via EXIT 128 toward Belt Route
- Take Exit 6 for 6200 S
- Keep left to take the ramp toward Easter/Cottonwood Heights
- Take a slight left to UT-190/E 6200
- Turn slight right onto S 3000 E
- Turn right onto E Cottonwood Pkwy
- The building will be on the left-hand side

From Park City

- Take I-80 W
- Take Exit 130 to merge onto I-215 S
- Take Exit 6 for 6200 S
- Keep left to take the ramp toward Easter/Cottonwood Heights
- Take a slight left to UT-190/E 6200
- Turn slight right onto S 3000 E.
- Turn right onto E Cottonwood Pkwy
- The building will be on the left-hand side

From South of Salt Lake City (Provo, Draper, Sandy)

- Take I-15 Northbound
- Take Exit 298 to merge onto I-215 E/Belt Route
- Take Exit 6 for 3000 E
- Keep far right at the fork, follow signs for 3000 E
- Merge onto 3000 E.

- Turn right onto Cottonwood Pkwy
- The building will be on the left-hand side

From Cottonwood Heights to Downtown

- Head East on W Cottonwood Pkwy toward S 3000 E
- Turn left onto S 3000 E
- Turn left onto 6200 S/Big Cottonwood Rd S
- Merge onto I-215 N
- Merge onto I-80 W toward Reno
- Take Exit 306 for 600 S
- Continue straight onto W 600 S/Martin Luther King Jr. Blvd
- Turn left onto W Temple
- Turn right onto 100 S
- Parking is on the left/north side (170 South Main Parking) by bus stop before Main Street
- 170 South Main Street, Suite 1000 is on the northwest corner of Main Street and 200 South
