Follow I-40-E to Exit 289 for Wade Ave. Take the Edwards Mill Rd. exit from Wade Ave. Turn left onto Edwards Mill Rd and continue on Edwards Mill Rd to Duraleigh Rd. Turn right on Duraleigh Road and continue on Blue Ridge Rd. Continue to the corner of Blue Ridge Rd and Lake Boone Trail.
