locations in Madison, Wisconsin. He successfully litigated and negotiated more than \$80 million in total secured debt as part of a confirmed plan of reorganization.

- *In re K&K Holdings, LLC* (Bankr. N.D. Ill 2014). Justin represented a commercial real estate management company that owned 20 commercial developments in the Chicago area and Southeastern Wisconsin, with over 100 commercial tenants. He successfully restructured loans on profitable locations and sold/surrendered other locations to lenders while reducing and eliminating debt for his client.
- *In re Ms. Sophia, LLC* (Bankr. E.D. Wis. 2013). Justin represented a property management company that owned over 40 residential rental properties in Milwaukee, Manitowoc, and Door County. With Justin's help, the company shed unprofitable locations and successfully restructured its loans on other properties. After a contested confirmation hearing that included expert-witness testimony, he successfully confirmed a plan that reduced the interest and extended the term of more than \$2.5 million in loans.
- *In re The Big Whale, LLC* (Bankr. E.D. Wis. 2011). Justin represented a company that owned nearly 50 Milwaukee County rental properties, helping it reach consensual agreements with five separate banks to restructure more than \$12 million in debt.
- *In re Bulk Petroleum Corp.* (Bankr. E.D. Wis. 2011). Justin assisted in the representation of a gasoline distribution company that owned numerous gasoline stations throughout the Midwest. Within this complex Chapter 11 case, he assisted in the sales of more than 100 c-store properties, successfully negotiating environmental issues, claim objections, financial projections, and tax claims. He also assisted with appellate briefs and district court briefs related to withdrawing the reference, appeals of sale orders, and tax disputes.
