Diversity & Inclusion Scholarship Award

A second-year student at the University of Wisconsin Law School was the recipient of the scholarship. Michael Best created the scholarship so it can be renewed for a student's third year, provided eligibility requirements are maintained.

Along with the possibility for full tuition awards for the second and third years, scholarship recipients will receive an offer to participate in the firm's summer associate program at the firm's Madison or Milwaukee office, and be paired with a Michael Best attorney who will mentor them during the scholarship.

The initiative was spearheaded by firm partner and Summer Associate Program Co-Chair Melanie Reichenberger, in collaboration with Michael Best's Diversity & Inclusion Committee, Recruiting Committee and Management Committee.

Lead Real Estate Firm in Historic Milwaukee Redevelopment Project

Michael Best took part in the redevelopment of the Historic Garfield Campus. The firm addressed all aspects of the Historic Garfield transaction, from conception to closing, including site acquisition, zoning and entitlements, environmental, taxcredit syndication, construction, and financing. The Historic Garfield Campus will be located in Milwaukee's Bronzeville Neighborhood and will include the Historic Garfield Apartments and The Griot mixed-use commercial development, which will serve as the new home for America's Black Holocaust Museum, a well-regarded cultural institution in the city.

Danielle Bergner, the Milwaukee office co-managing partner, was the lead attorney on the project and donated a significant number of pro bono hours to this effort.
